<u>Overview:</u> The Product Specific Terms of Use (E300), have been updated to reflect changes due to updated Esri policies, and clarification language derived from Esri Product Management and customer requests.

<u>General Changes:</u> Most changes are grammatical changes or updates to wording to allow for better flow of what the statement is supposed to imply. Major changes described below.

Why: Product name change.

Where: Footnote 4

Change:

- 4. When used with ArcGIS Enterprise Workgroup
- 4. Limited to 1 four-core server.
 - Can be installed on a separate machine.

Why: Clarified that footnote 4 applies to ArcGIS Enterprise Workgroup above in the list of Products. Removing unnecessary language in footnote 4 to work with that change.

Where: Footnote 17

Change:

17. Customer shall not redistribute Oracle JDBC Driver or its documentation that is included with this Product. Oracle is a third-party beneficiary of this Agreement with respect to the Oracle JDBC Driver.

Why: Clarifying that this footnote applies to the Oracle JDBC Driver only.

Where: Footnote 68

<u>Change:</u> 68. Customer may not store the geocoded results generated by World Geocoding

Service without an ArcGIS Online subscription. 68. Customer may use the data accessible through Infographics Service for display purposes only and may not save any data accessible through this service.

Why: The first sentence of footnote 68 was clarified and moved to create a new footnote 66.

Where: Footnote 72

Change:

72. May be used for the benefit internal business purposes of Customer's qualified NGO/NPO organization.

Why: Original footnote 72 was specific to NGO/NPO organizations, but was unnecessary. This footnote is now more general.

Where: Footnote 73

Change:

73. May be used for the benefit of press or media organizations.

73. Reserved.

Why: Footnote 73 is no longer needed as footnote 72 can cover this permitted use.

Where: Footnote 84

Change:

84. Does not include a Deployment License for commercial use. Does include a Deployment License for non-commercial or educational use.

Why: This footnote is clarification that these Products to include a Deployment License for non-commercial or educational use only.

Where: Footnote 87

Change:

87. Accessing Parcel Fabric services provided by ArcGIS Enterprise is prohibited except through ArcGIS Pro Standard and ArcGIS Pro Advanced.

Why: This is a new footnote that is required for Parcel Fabric services.
